- 3. LETTER OF INVITATION
 LETTER FROM EMPLOYER AND THREE MONTHS STAMPED
 BANK STATEMENT.
- **4 TRAVEL ITINERARY**
- 5 COPY OF PASSPORT (INCLUDING PASSPORT)
- 6 COPY OF YELLOW FEVER CERTIFICATE
- 7 HOTEL BOOKING (IF APPLICABLE)

- 1. NOTE VERBALE FOR ALL DIPLOMATIC, OFFICIAL AND UN PASSPORT HOLDER;
- 2. ONE COMPLETED APPLICATION FORM;
- 3. TWO (2) PASSPORT SIZE PHOTOGRAPHS;
- 4. COPY OF PASSPORT (INCLUDING DIPLOMATIC PASSPORT)
- 5. COPY OF DIPLOMATIC IDENTITY CARD
- 6. COPY OF TEMPORARY RESIDENCE PERMIT

PLEASE NOTE THE FOLLOWING

- 1. SUBMISSION OF APPLICATION FOR VISA IS FROM 09:00 A. M TO 12:00 NOON, MONDAYS TO FRIDAYS.
- 2. PROCESSING TIME FOR REGULAR VISA IS FIVE (5) WORKING DAYS.
- 3. PROCESSING TIME FOR EXPRESS OR EMERGENCY VISAS WILL BE WITHIN 24 HOURS, PROVIDED ALL DOCUMENTS UPON SUBMISSION ARE IN ORDER
- 4. THE EMBASSY DOES NOT PROCESS WORK PERMITS OR DRIVERS' LICENSES. THIS IS DONE IN MONROVIA, LIBERIA.
- 5. FEES FOR EXPRESS OR EMERGENCY VISA IS **DOUBLE THE AMOUNT CHARGED PER VISA, IN ACCORDANCE WITH THE CATEGORY OF VISA REQUESTED**
- 6. ALL VISA FEES PAID ARE NONREFUNDABLE
